

PRIVACY POLICY

Personal Data

§ 1

1. All personal data that is obtained from the Customer during placing an order at www.boho.lu or during using the store, as well as for the purpose of complaint procedure are processed to the extent agreed on with the Customer and according to the requirements defined in Polish law, especially with the Personal Data Protection Act of 29 August 1997 (consolidated text: Journal of Laws of 2002, No 101, item 926, as amended) and the Act on Electronic Services of 18 July 2002 (Journal of Laws of 2002, No 144, item 1204).

§ 2

1. Personal Data Administrator is BOHO M. Bochenek and A.Swiech s.c. with a registered office in Krakow, Wesele 47/4, registered under Tax Identification Number: 677 238 00 75 and REGON number: 123 060449.
2. The Administrator may charge another entity with processing collected personal data of the Customer on the basis of an agreement concluded with him under the Personal Data Protection Act of 29 August 1997.

§ 3

1. The Customer of boho.lu shall have the right to access their personal data, to verify or correct it as well as to demand that it is removed by addressing a requirement to BOHO M. Bochenek and A. Swiech civil partnership.
2. Removing of the personal data from the set of BOHO M. Bochenek and A. Swiech civil partnership is made at the request of the Customer.

§ 4

1. BOHO M. Bochenek and A. Swiech s.c. processes personal data of the Customers to the extent necessary for the performance of its duties arising from the Regulations. Personal data of the Customers provided in correspondence with the store shall be used in order to answer to the Customer's questions, especially in order to consider any possible claims. BOHO M. Bochenek and A. Swiech s.c. may process obtained personal data of the Customer also in other purposes permitted by law, defined in the acts referred to in § 1 sec.1.
2. BOHO M. Bochenek and A. Swiech s.c. may process personal data of the Customer for statistical or marketing purposes with the Customer's consent, also in the future as well as send commercial information from BOHO M. Bochenek and A. Swiech s.c to the list of the Customer's telephone numbers and e-mail addresses.

§ 5

The personal data collected by BOHO M. Bochenek and A. Swiech s.c. may be disclosed to authorised organs of public administration within the scope of the law.

Cookies

§ 6

1. BOHO M. Bochenek and A. Swiech s.c. use cookies that are small text files that are stored in Contractor's terminal equipment. Cookies may be read by BOHO M. Bochenek and A. Swiech s.c. ICT system.
2. BOHO M. Bochenek and A. Swiech s.c. keeps the cookies in Customer's terminal equipment, subsequently it gains access to the included information for the following:
 - provision of selling goods offered by BOHO M. Bochenek and A. Swiech s.c.,
 - any marketing and statistical reasons of BOHO M. Bochenek and A. Swiech s.c. as well as of any cooperative operators,
 - securing of surveys and internet surveys conducted by BOHO M. Bochenek and A. Swiech s.c. against voting many times by one person,
 - showing advertisements selected on the basis of the Customer's preferences.

§ 7

1. BOHO M. Bochenek and A. Swiech s.c. informs the Customers about possibility to configure the web browser that disables keeping or removing cookies on the Customer's terminal equipment.
2. BOHO M. Bochenek and A. Swiech s.c. suggests also that cookies may be removed by the Customer after saving them by BOHO M. Bochenek and A. Swiech s.c. using appropriate function of the web browser, programs for this purpose or applicable system tool, this is used by the Customer.
